<u>STAFF AWARDS & RECOGNITION</u>: Employee Mary Capuano was recognized this time for her duties and dedication, she also received a special parking space for 2 months.

DSS TELEPHONE SYSTEM:

This is a 20 year old system. He has spoken to R. Wheeler, and will work with R. Caponera on the submittal of an RFP.

HOMELESS SERVICES DRAFT RFP:

- P. Mossman updated the committee on the number of people housed by the Department in local motels has reached a 22-month low. The County had 32 people placed in motel rooms on March 1, down from 94 in November. P. Mossman stated the figures are a result of a number of factors, including warm weather which is reducing heat costs, higher rent subsidies from the county, and at least three cases over the past year in which social services recipients were denied shelter for violating rules for receiving benefits.
- P. Mossman was given the approval to submit an RFP for a new homeless shelter. He will work with the County Attorney and the Controller before submitting. This will be published as a legal notice and will be forwarded to organizations such as Maranatha, Catholic Charities, Family of Woodstock, and the Mental Health Assoc. of Columbia-Greene Counties, Inc.

OFFICE FOR THE AGING: K. Jablonka

Mayors for Meals Event: 8 to 9 Supervisors donated their time to help deliver meals to the seniors.

NYS Budget: Flat funded, don't have any new numbers at this time.
