**WHEREAS, this work is necessary to develop the cost of moveable equipment which will be included in the
Certificate of Need (CON) application to the NYSDOH; and**

**WHEREAS, Fontanese Folts Aubrecht Ernst Architects, P.C. has presented a proposal to provide
additional services for the referenced project; and**

WHEREAS, the Additional Services include the following:

- 1. Visit the projects site to perform an inventory of existing furniture intended to be relocated to the new facility;**
 - 2. Document existing furniture and photograph items;**
 - 3. Review new furniture options with the Owner;**
 - 4. Prepare initials furniture layouts utilizing the proposed floor plan;**
 - 5. Review Furniture layouts with the Project Team, Revise and present again if necessary for final approval;**
 - 6. Prepare furniture listing and related costs for submittal to NYSDOH;**
 - 7. Provide general follow-up and project communications related to this task;**
- The proposed fee for the above, including all reimbursables is \$12,000.00**

additional services for an amount not to exceed \$12,000.00, subject to review and approval by the County
