AUTHORIZING THE CHAIRMAN OF THE BOARD OF SUPERVISORS TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT IN THE AMOUNT OF \$173,601.00 WITH C & S ENGINEERS, INC. OF SYRACUSE, NY FOR THE PROVISION OF LAND ACQUISITION SERVICES (APPRAISALS, SURVEY MAPPING, ENVIRONMENTAL PHASE I, ETC) FOR THE COLUMBIA COUNTY AIRPORT R/W21 END LAND ACQUISITION AND RSA IMPROVEMENT PROJECT

UPON, recommendation of the Public Works Committee at a meeting held on the 24th day of August 2011, the Budget & Salary Review Committee at a meeting held on the 25th day of August 2011; and of the Finance Committee at a meeting held on the 6th day of September 2011;

WHEREAS, this agreement provides for updated land acquisition services such as appraisals, surveys, golf course estimates, etc. and also includes provisions for full Federal and NYS Reimbursements of the original 2008 appraisals and other related land acquisition services performed by C & S Engineers for previous attempts at acquiring lands necessary for R/W 21 RSA Improvements; and

WHEREAS, all costs are to be reimbursed at 95% Federal, 2.5% State and 2.5% local funds;

NOW, THEREFORE BE IT

RESOLVED, that the Chairman of the Columbia County Board of Supervisors is hereby authorized to execute a Professional Services Agreement in the amount of \$173,601.00 with C & S Engineers, Inc. of Syracuse, NY for the for updated land acquisition services such as appraisals, surveys, golf course estimates, etc. and also includes provisions for full Federal and NYS Reimbursements of the original 2008 appraisals and other related land acquisition services performed by C & S Engineers for previous attempts at acquiring lands necessary for R/W 21 RSA Improvements; and be it further

RESOLVED, that the above contracts are subject to review by the County Attorney's Office; and be it further

RESOLVED, all costs are to be reimbursed at 95% Federal, 2.5% State and 2.5% local funds;

RESOLVED, that certified copies of this resolution be forwarded to the Engineering Department (8 certified copies), the Accounts Payable Department, the Commissioner of Public Works, the Columbia County Attorney and the Columbia County Treasurer.
