**RESOLUTION AUTHORIZING THE CHAIRMAN OF THE COLUMBIA COUNTY BOARD OF SUPERVISORS TO AWARD THE CONSTRUCTION CONTRACT IN THE AMOUNT OF \$5,712,014.00 TO A. COLARUSSO & SON, INC. OF HUDSON NEW YORK FOR THE REHABILITATION OF PORTIONS OF COLUMBIA COUNTY RTES. 7 & 7A AND THE REPLACEMENT OF BIN 3342150-BROWN'S BRIDGE, CARRYING CO. RTE. 7A OVER THE ROELIFF JANSEN KILL IN THE TOWN OF COPAKE**

UPON, recommendation of the Budget & Salary Review Committee at a meeting held on the 23<sup>rd</sup> day of February 2011, of the Public Works Committee at a meeting held on the 24<sup>th</sup> day of February 2011 and of the Finance Committee at a meeting held on the 1<sup>st</sup> day of March 2011;

WHEREAS, six (6) sealed bids were publicly opened on December 21, 2010, with A. Colarusso & son, Inc. of Hudson, NY being deemed the lowest responsible bidder for this locally administered Federal & NYS-Aided Transportation Project; and

WHEREAS, this budgeted project is funded with 80% Federal, 15% NYS Marchiselli and 5% County funds;

NOW, THEREFORE BE IT

RESOLVED, that the Chairman of the Columbia County Board of Supervisors is hereby authorized to execute a contract in the amount of \$5,712,014.00 To A. Colarusso & Son, Inc. of Hudson, NY for the rehabilitation of portions of Columbia County Rtes. 7 & 7a and the replacement OF BIN 3342150-Brown's Bridge, Carrying County Rte. 7A over the Roeliff Jansen Kill in the Town of Copake; and be it further

RESOLVED, this budgeted project is funded with 80% Federal, 15% NYS Marchiselli and 5% County funds; and be it further

RESOLVED, that this contract is subject to the approval of the County Attorney's Office; and be it further

RESOLVED, that certified copies of this resolution be forwarded to the County Engineering Department (6 certified copies), the Accounts Payable Department, the Commissioner of Public Works, the Columbia County Attorney and the Columbia County Treasurer.
