AUTHORIZING DISTRIBUTION OF MORTGAGE TAX MONIES

UPON, recommendation of the County Government Committee at a meeting held on the 24th day of April 2012, the Budget and Salary Review Committee at a meeting held on the 26th day of April 2012, and the Finance Committee at a meeting held on the 1st day of May 2012;

WHEREAS, the semi-annual report of Mortgage Tax Monies has been reviewed and accepted by the Board of Supervisors;

NOW, THEREFORE BE IT

RESOLVED, that under this warrant the County Treasurer of Columbia County, pursuant to the provision of Section 261 of the Tax Law, is authorized and directed to pay that portion of mortgage taxes for the semi-annual period of October 2011 – March 2012, which is applicable for distribution within the County and which is in the Aggregate amount of \$590,306.74 per the below schedule , as approved by NYS Department of Tax and Finance, to be so distributed as follows:
